- BWSR has traditionally requested more money, we'll wait and see
- biannual budget request is very helpful
- Package grant, 3 parts BWSR (LWM, WCA, Shoreland) is responsible for MPCA add on SSTS, feedlot
- Only talking about BWSR pieces to make more efficient
  - o Program needs help Roseau County had 5 imminent health threats and they were delayed until November 15, and now 3 have to move because the systems won't be fixed over winter.
  - o Can't spend first, need predictability

- Called a block grant, but not really a block grant.
- Right now, can't split the match, going forward trying to give county flexibility
- Went through options for improving administrative efficiency

- Intermediate not being able to treat high strength waste
  - o Appreciate other counties support
- Grant amounts
- New legislation 2014 tank fee changes,
- Possible legislation pipe layers still have to be certified, but won't need separate bonds
- Seasonal campgrounds estimated peak flow
  - O Holding tanks can take away from the peak flow numbers so it wouldn't require a state permit
- Lapse certification: one year to take test for area that you missed; give more flexibility test offered every 60 days.
