- MACPZA Website Update Bill Patnaude
 - o Website will be reviewed to determine where updates are needed, which will include expanding the steering wheel concept started by Steve Just.

New Business

- Conference call with BWSR
 - O Due to technical issues, the connection with BWSR was never realized. The purpose of the call was to provide BWSR with talk/feedback on their legislative directive to develop a non-point priority funding plan.
 - Legislature tasked BWSR to prepare and post a priority funding plan; due by April 1st.
 - Comments may still be made after plan has been submitted in April.
 - Since the Biennial Budget Request takes many hours to complete, the Board felt BWSR should use information in the BBR for prepare their priority funding plan.
- Review Draft Fact sheets
 - o Fact sheets relate to drainage rules and conservation delivery in Minnesota
 - o WCA should be called out with a bullet as it appears to be an after-thought
 - o Sheets should be reviewed by drainage authorities in each county to see if accurate
 - o Not much information about Ag BMP Program dollars, and local government involvement seems to go unrecognized
 - o With little updating, the fact sheets provide good information
- Review 2015 MACPZA Meeting Schedule
 - o Meeting locations were tough to locate for 2014 MACPZA Meetings; finding the same problem for 2015. Will continue to research potential locations.

- Gopher State One Call
 - Counties have been contacted regarding the possibility of adding language to their permits regarding Gopher State One Call.
- Review 2013-2014 MACPZA Board Goals/Actions
 - o Direct Professional Development Commission to update "Welcome to MACPZA" packet
 - o 1. Membership Support add "d. Develop new welcome packet for new members."
- Review all MACPZA Policy Statements
 - o Direct By-Laws Committee to review all MACPZA Policy Statements as possible updates to the By-Laws, which would be voted on at Annual Meeting in October
- District Representatives and Alternates for B, D and F
 - o Districts B and D Reps and Alternates will remain the same
 - o Dale Oolman will become Rep for District with F; no Alternate for F at this time
- Review 2014 MACPZA Committees
 - o If Treasurer's position is to become appointed, directed By-Laws Committee to look at doing the same for the Audit Committee
 - o MIDS Committee has finished their tasks

MSP: Bill/Terry to disband the MIDS Committee and thank Dave Rush for representing MACPZA.

- MPCA Commissioner Meeting Review
 - Meeting was held January 6th with discussions focusing on MACPZA's concerns regarding changes of who collects the tank fees
 - Rulemaking, Feedlot Assessments, APO authority for PCA, Water Re-use Policy, Solid Waste, and "UnSession"

- Department of Commerce Solar Meeting Update
 - o How do counties plan for large scale solar?
 - o How would state-wide uniform permitting of solar impact counties? Would it be to avoid local control over solar developments?
 - o PUC and DOC are interested in working with counties to develop standards
- Local Government Water Roundtable Meeting Update
 - o 1W1P watershed boundary map on BWSR website
 - o Counties may apply for one of 6 Pilot Projects that will be given \$.
 - o Unsure on how drainage will be handled through the Plans
 - An Interagency group has been meeting for 5 years looking at 3 groundwater management areas, specifically at irrigation and drainage
 - O Suggestion made to have Interagency group provide update at Spring Conference and to explain what groundwater means

AMC Updates – Annalee Garletz

- Governor Dayton visited AMC to discussion "Unsession" ideas
- Working on Legislation for MACPZA's Recording Bill
- Department of Ag is working with EPA and SWCDs on Ag Certification, including the development of score sheets. The Pilot areas encompass four watersheds that are located within the following counties: Wilkin, Martin, Faribault, Jackson, Stearns, Otter Tail, Olmsted, Wabasha, and Winona. Update on Ag Certification would also be beneficial to hear at Spring Conference.
- Training suggestions for Spring Conference include "How to Manage Contracts County Protection" and "Manage Difficult Situations – BWSR"
