Waters of the US Update - Annalee

- Meeting yesterday of local government advisory committee to the EPA, administrator of EPA flew in, Met later with Mayors of Minneapolis/St. Paul on air quality later, made up of officials, administrators from all over the US. Advisory committee of EPA, first of 4 listening sessions.
- Talked about what the rule was, what they felt it wasn't
- •The committee said to EPA that the rule is unclear
- Probably extend comment period past July 29 (current deadline)
- NACO comparing old rule and new rule.
- •Agencies will accelerate the review, the review will be based on science. Causes confusion because of past practice.
- Need pointed questions and examples of things we need definitions on.
- •Annalee, Next week will put together a letter on what AMC Board may want to decide.
- •What does this mean in particular to drainage ditches.

Climate Change – Annalee

- Climate adaptation team on June 10th, brief presentation from AMC to see what they would like more information from the state on.
- Emergency response, floodplain management, reliability, road, other impacts for examples
- From a Planning Standpoint we need to think about agricultural water and residential water resources.
