- A lot of bills introduced this year. Of over 4000 total bills introduced 80 we sent to the Governor.
- 77 became law and 3 vetos
- Discussion on buffer requirements, 50 feet average with 30 feet minimum. Public waters not changing, DNR to map.
- Counties can still enforce current law.
- Lot split bill. This summer we can figure out what exactly needs to be in the bill and it needs to go through taxes. Try again next year.
- Work on solar siting in the interim
- Kristi talk to Steve Drazkowski about split bill to explain what we do.
