Climate / Energy Partnership Grants

The Minnesota Pollution Control Agency (MPCA) invites applications from cities and counties for projects that will strengthen and encourage partnerships between citizens and local government in reducing community greenhouse gas emissions and energy use.

Small grants of up to \$10,000 may be awarded by the MPCA's Prevention and Assistance Division (through its Program Development and Implementation Technical Assistance Grants) for selected projects. As funds are very limited for this program, it is recommended that applications be sent in as early as possible in calendar year 2008. Additional funds may be available for these grants in future fiscal years.

The purpose of these grants is to increase cooperation between citizens and local governments, and to foster the development of local models and approaches that will effectively address climate and energy challenges. MPCA will share information and success stories from these projects with other communities.

Technical assistance may also be provided by the Minnesota Climate Change Corps (CCC) an initiative of the Minnesota Retired Engineers Technical Assistance Program (see http://www.pca.state.mn.us/retap). The CCC is comprised of skilled, retired professionals who work on either long or short-term assignments to help reduce a community's carbon footprint. City and county governments are the Corp's priorities for assistance, which is provided without cost to the community.

The MPCA seeks to support a variety of approaches involving citizens working in partnership with their local government. Examples of projects that may be submitted are:

- Creating or strengthening a citizen climate and/or energy task force for a city or county.
- Preparing a climate and/or energy action plan with active citizen involvement that will be formally adopted by the community.
- Supporting ongoing partnerships between neighborhoods/blocks and city government that will address climate and energy issues.
- Creating or using a network of block or neighborhood leaders to address climate and energy issues in a city.
- Other activities through which citizens will partner with a city's or county's climate and energy activities and which will result in concrete outcomes.

Projects should strive to meet the goals of the Next Generation Energy Act that was signed into law in 2007. For more information about this legislation see http://www..nextstep.state.mn.us/res_detail. cfm?id=4034.

Eligibility: Only city or county governments are invited to submit applications under this category. Cities or counties that have signed the US Mayor's Climate change

Happenings in Fillmore County

Have you ever thought of what it would be like if Minnesota had the same climate as south Florida? We would have construction season all the time. No breaks at all. It's kind of nice having winter. At least the number of customers coming in the office slacks off and we take a breather.

One of the biggest issues to be discussed this winter has been campgrounds. Fillmore County has no lakes; only rivers. With the beautiful limestone cliffs and scenic river valleys, campers seem to flock to the campgrounds come summer. To be sure, the best campsites are those found along the river. Everyone wants to camp as close to the river as they can.

Last summer, southeast Minnesota experienced some very strong storms and heavy rains. Rivers over flowed their banks and people lost their lives. Many campgrounds suffered extensive damages. We were fortunate in Fillmore County in that no people residing in campgrounds in our county lost their lives. However, it did raise the issue of safety and camping along the river.

"How much should county government do to protect people from themselves?" That is the question. I don't know as I have the answer but our PC and County Board have undertaken the task of trying to sort it out. We have just adopted a new Campground Ordinance. The county will no longer allow RV's in the floodplain. All campgrounds must be closed during December, January, and February and no one may occupy a camper when the campground is closed. Other changes will be discussed in the next few months. It will be very interesting to see how this all turns out.

Workshops on Agriculture Emergency Response

The Department of Agriculture, the University of Minnesota, and the Department of Public Safety, Division of Homeland Security and Emergency Management are hosting a series of regional workshops to assist counties as they work to integrate agriculture into county-level emergency response plans. The purpose of these workshops is to:

- Provide county emergency preparedness and planning with a broad picture of agriculture in their county/ region
- 2. Provide tools to supplement agricultural emergency preparedness and response planning, and
- 3. Identify agriculture emergency preparedness and response resources available at the county, state and federal level.

A number of counties have formed Local Agriculture Emergency Preparedness Workgroups. Others have added Agriculture to pre existing Local Workgroups. These workgroups meet regularly to discuss agriculture emergency preparedness and response issues, provide technical expertise and assist the Emergency Management Director in emergency response planning and building out county Agriculture emergency response capabilities and capacities.

County staff that should attend the workshops includes emergency managers, feedlot officers, and solid waste officers.

Wetlands Restoration Strategy for Minnesota

FAST FACTS

Purpose: A wetlands restoration strategy can provide guidance for strategic decision making about which of the many potentially restorable wetlands should be prioritized for public and private investment.

Co-sponsors: BWSR, DNR, PCA, MDA, Mn/DOT

Key elements of strategy:

- 1. Prioritize wetland restorations for greater benefit.
- 2. Enhance coordination of wetland restoration efforts across state and federal agencies, local government units, and non-governmental organizations.
- 3. Aim funding towards prioritized wetland restoration outcomes.

Participatory process:

- Strategy development through a small design team.
- Prioritization approach (GIS-based) is currently being developed and tried out in two watersheds through meetings with local contacts (including county staff).
- Web-based stakeholder feedback surveys.
- Not relying on large meetings with stakeholders to get it done.
