# 11:00 a.m. Environmental Review: Updates and New Digital Tools

EQB staff share the latest updates to Minnesota's environmental review program including new guidance, resources, tools, and a tutorial on using the Climate Calculator (launching later this summer). The Climate Calculator will help estimate emissions for many different types of projects. It also includes suggested mitigation and adaptation strategies. The calculator is meant to provide a defensible answer to the EAW form's climate question, but can also be used as a planning tool.

## Jesse Krzenski, Environmental Review Program Administrator | MN Environmental Quality Board

Jesse Krzenski is the environmental review program administrator at the Minnesota Environmental Quality Board with two years helping environmental review practitioners with interpreting the rules of environmental review. He specializes in environmental review rules and uses that experience to provide technical assistance to program users.

### Steph Aho, Greenhouse Gas Data Analyst | MN Environmental Quality Board

Steph Aho is the greenhouse gas data analyst at the Minnesota Environmental Quality Board. For the past 16 months she has been managing the construction of EQB's climate calculator, a tool designed to make the Environmental Assessment Worksheet process more efficient for project proposers. With the completion of the climate calculator this month, Steph's work will transition to training and supporting calculator users as they begin navigating this new tool.

#### Jim Drake, Natural Heritage Review Specialist | MN Department of Natural Resources

Jim Drake works for the DNR as a Natural Heritage Review Specialist. In that position, he reviews proposed projects for potential impacts to rare natural features and provides measures to avoid or minimize those impacts. This included being part of a team mapping vegetation at over 60 national parks across the US. Jim has a B.S. in Biology and a Master's in Conservation Biology.
